**Foundation Description and Purpose:**

Amigos Near Foundation is a not-for-profit organization with a mission to "help underprivileged kids around the world". The primary focus of the foundation are orphan and cancer patient children. The foundation activities include distribution of toys, clothing, food, water, school and other supplies to children in need.

The foundation activities are fully supported by member and volunteer participation for which no compensation expenses are incurred. Foundation members and volunteers offer their time to support and carry out the activities organized by the foundation at no extra cost to the organization. This support included accountant's December 31, 2013 compilation fees which were entirely covered by the members of the Board.

The Internal Revenue Service has ruled that the charitable corporation, Amigos Near Foundation Inc. is a tax-exempt organization which is exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code.
